**BLUE HILL/BROADACRES GOLF COURSE**  
**2011 ASSOCIATE AND CORPORATE PERMIT INFORMATION**

The Associate Membership is open to anyone who is not a resident of the Town of Orangetown and not entitled to a resident permit. Membership fee for the Associate permit is \$95 for the 2011 season. The Associate Membership will allow members to call five (5) days in advance for a tee time. The Associate Membership will allow members to play at an Associate's rate, which is discounted from the non-resident rate. The Associate Membership allows members to play at both Blue Hill and Broadacres Golf Course. Greensfees and cart fees will be collected from players on the day of play.

The Corporate Membership is open to any corporation/business or non-resident property owner situated in the Town of Orangetown. Membership fee for the Corporate permit is \$200 for the 2011 season. Each membership will be assigned a corporate identification number (ID#) and will have one contact person who can call for tee times. Reservations may be made five (5) days in advance. Each corporation/business or non-resident property owner will be entitled to make two (2) foursome tee times per week. The Corporate Membership will allow golfers to play golf at either Blue Hill or Broadacres by paying a corporate rate which is discounted from the non-resident rate. Greensfees and cart fees will be collected from players on the day of play.

For the safety of all golfers, it is the responsibility of the permit holder to be familiar with the rules and etiquette of the game of golf. Failure to follow these rules can result in permit revocation and suspension of playing privileges.

\*All players must present their current permit along with a Photo ID at the Pro Shop when they play.

**REGISTRATION PROCEDURES:**

All Associate and Corporate members must obtain a permit in 2011. Permits will be available at the Parks and Recreation Office, located at Veteran's Memorial Park, 81 Hunt Road, Orangeburg, New York at the following times:

**Monday: 3:00pm – 7:00pm**  
**Tuesday, Wednesday, Thursday and Friday: 10:00am – 4:00pm**  
**Saturday 9:00am – 12:00 noon**  
**Beginning Monday, May 23<sup>rd</sup> , Monday thru Friday, 10:00am-4:00pm ONLY!**

The following is necessary at time of permit registration:

- Valid Driver's License or other Photo ID with address. Non-drivers can show Passports.
- Corporate members must show proof of corporation / business.

**WEEKDAYS AND WEEKENDS:** Current permit holders will continue to use their established user I.D. and password for the automated online tee time reservation system. New permit holders will use their household I.D. number as their login and their last name as their password. They will have the ability to change their password the first time they use the system. Associate and Corporate permit holders will be able to utilize the automated phone system by using their nine (9) digit permit number located on the back of their key FOB as their login number.

1) *Associate and Corporate Permit Holders:* May reserve a weekday starting time five (5) days in advance, in order to secure a tee time to play at Blue Hill or Broadacres Golf Course.

2) *Non-Permit Holders:* May reserve a weekday starting time three (3) days in advance, in order to secure a tee time to play at Blue Hill or Broadacres Golf Course.

When booking tee times through the automated system for Blue Hill Golf Course, you will be asked to select a starting course. You will choose between Pines, Woodlands or Lakeside. Course staff will make every effort to honor this request; however, your starting location may change due to course conditions.

**PLEASE NOTE:** All cancellations must be made through the Pro Shop by 11:59 p.m. one day prior to the day of play. (Example: The system will not accept tee times for Saturday after 11:59 p.m. on Thursday). Repeated no shows without cancellation could result in a revocation of system access.

Associate Members may also be allowed to participate in the Town's "Seasonal Weekend Golf Program" based on availability. After offering the 10 and 20 weekend tees times to resident permit holders first, should any time slots go unfilled, associate members may apply to secure one of these tee times, either individually or any number up to a foursome, provided that all players must be Associate members and must abide by the same rules and regulations as resident permit holders regarding prepayment for the seasonal times and any fees associated with the program. Tee times would still be charged at the Associate Member discounted rate.

**WEEKEND SEASONAL STARTING TIMES:** Reservations for the weekend seasonal starting time program may be obtained by completing the seasonal request form offered under the following programs: **FULL SEASON** (20 Weeks) OR **HALF SEASON** (10 Weeks). Programs are open to Associate permit holders during the 2011 season.

1) Weekend seasonal starting times are: 20-Weeks (Full Season): **\$3,920.00** Per Foursome (\$980.00 per player), and 10-Weeks (A or B Half Season): **\$1960.00** Per Foursome (\$490.00 per player). This rate includes a **\$3.00** per round reservation fee. *All seasonal tee time fees shall be paid up-front to reserve the assigned time. (See enclosed schedule)*

2) These seasonal times are prepaid, and new groups will be assigned on a space available basis.

3) There are NO REFUNDS in this program, and there will be no refunds due to weather conditions unless the course is officially closed. This weekend program is for Associate permit holders. All guests will be charged the seasonal alternate rate, and notification must be given in advance to the Pro Shop for any guest substitutions.

Non-compliance with these regulations can result in full suspension of all golf privileges and greensfees.

PLEASE NOTE THE FOLLOWING REGULATIONS:

1) **Seasonal Weekend Program is limited to 2011 Orangetown and Associate Permit Holders ONLY.** Associate members or Non-members can be used as alternate substitutes for Resident members and Associate members; however a ratio of 3 Resident members to 1 Non-member/Alternate or 3 Associate members to 1 Non-Member/Resident is required at the time of play. Notification and approval in advance must be given for any non-resident/associate substitution. Alternate substitutes must pay an additional fee of \$34.00 for Non-Residents and \$29.00 for Associate Members. This payment must occur at the Pro Shop, and the alternate must present his receipt from the Pro Shop to the starter for play.

2) 2011 Permit Holders may only hold one (1) seasonal starting time during the course of the season; however a seasonal starting time holder may substitute on another day. Foursome Fee: \$980.00 per player (full season); \$490.00 per player (half season).

3) Seasonal dates may be canceled due to family or business commitments, by notifying the Pro Shop one (1) week in advance of the date of change. All seasonal time holders MUST notify the Pro Shop in advance of any available openings due to illness to receive seasonal credit.

PAYMENT SCHEDULE: \$980.00 per Associate Member due upon acceptance of assigned time (Full Season)  
\$490.00 per Associate Member due upon acceptance of assigned time (Half Season)
