## FINDINGS OF FACT:

- 1. The Board found that the project consists of a natural gas generator in connection with a wireless communication facility at the Dexter Plaza location. The generator is necessary to ensure that the facility will continue to operate during periods of prolonged power outages.
- 2. The Board found that the proposed generator would be located in an interior court yard and would not visible from the street.

- 3. The Board found that a fence with brown slats would screen the generator.
- 4. The Board found that the area has experienced flooding in the past, and the applicant would review the situation.
