

At the time and place of the public hearing specified above, all interested persons will be given an opportunity to be heard.

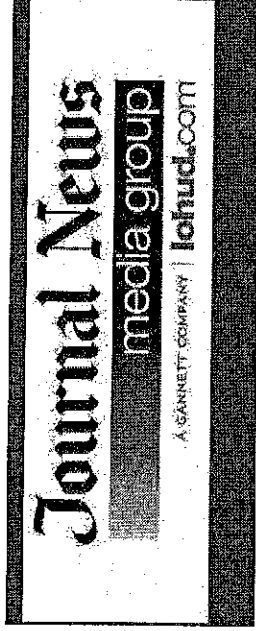
