

NOTICE OF ANNUAL ELECTION
TAPPAN FIRE DISTRICT

PLEASE TAKE NOTICE that the Annual Election of the Tappan Fire District will take place on December 8, 2020, between the hours of 6:00 P.M. and 9:00 P.M. at the firehouse located at 123 Washington Street, Tappan, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2021 and ending December 31, 2025; and

To vote upon the following proposition:

SHALL the bond resolution of Tappan Fire District, in the Town of Orangetown, Rockland County, New York, entitled:

“BOND RESOLUTION OF THE TAPPAN FIRE DISTRICT (“FIRE DISTRICT”), IN THE TOWN OF ORANGETOWN, ROCKLAND COUNTY, NEW YORK, ADOPTED OCTOBER 28, 2020, AUTHORIZING THE PURCHASE OF A LADDER TRUCK, INCLUDING APPARATUS AND EQUIPMENT USED IN CONNECTION THEREWITH, FOR USE BY THE FIRE DISTRICT; STATING THE ESTIMATED MAXIMUM COST THEREOF IS NOT TO EXCEED \$1,300,000; APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE; AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$1,300,000 BONDS TO FINANCE SAID APPROPRIATION; DETERMINING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID FIRE TRUCK IS TWENTY (20) YEARS; DETERMINING THAT, PURSUANT TO THE STATE ENVIRONMENTAL QUALITY REVIEW ACT (“SEQRA”), THE ACQUISITION OF SAID TRUCK IS A TYPE II ACTION AND DOES NOT REQUIRE ANY FURTHER REVIEW; PROVIDING FOR THE LEVY OF TAXES TO BE COLLECTED TO PAY THE PRINCIPAL OF AND INTEREST ON SUCH BONDS; AND PROVIDING THAT, IN LIEU OF THE ISSUANCE OF BONDS AUTHORIZED BY THIS RESOLUTION, THE FIRE DISTRICT IS AUTHORIZED TO ENTER INTO ONE OR MORE INSTALLMENT PURCHASE CONTRACTS TO FINANCE THE PURCHASE OF SAID FIRE TRUCK, THE TERMS OF WHICH SHALL NOT EXCEED TWENTY (20) YEARS,” Be Approved?

All residents of the Tappan Fire District, who are duly registered to vote with the Rockland County Board of Elections on or before November 16, 2020 shall be entitled to vote at this election.

Any person desiring to have his or her name appear on the ballot for the above office must have filed a written request with the Secretary of the Fire District not later than November 18, 2020.
