For "Twenty-Four/Seven" parking permits, the fee shall be \$300.00 per year and \$150.00 per half-year;

For "Overnight" parking permits, the fee shall be \$200.00 per year and \$100.00 for a seasonal permit valid November 15th through April 15th;

For "Municipal" parking permits, the fee shall be \$110.00 per year and \$55.00 per half-year;

For "Merchant" parking permits, the fee shall be \$10.00 per year.

"Merchant" parking permit holders may park at designated "Merchant Only" yellow-colored parking meters and must pay the meters as directed.
