FINDINGS OF FACT:

- 1. The Board found that the applicant proposed to expand an existing structure and has obtained Preliminary Site Plan Approval Subject to Conditions from the Planning Board and the needed zoning variances from the Zoning Board of Appeals.
- 2. The Board found that the façade material consisted of Tilt-up Concrete Panels in Benjamin More 1457, or equal; with a highlight color of Benjamin Moore 1459, or equal. Also, on the façade would be Synthetic Stone in Boral Country Hedge Stone, Hudson Bay, or equal. The door and window frames would be aluminum in white and the synthetic stucco coating would be in colors to match the Tilt-up concrete panels and highlight coloring, all as noted on the submitted architectural plans prepared by Barry Terach, R.A.
- 3. The Board found that lighting would be placed around the building entryway.
- 4. The Board found that the applicant shall reappear at ACABOR for review and approval of the project signage.

The hearing was then opened to the Public. There being no one to be heard from the public, the Public Hearing portion of the meeting was closed.
