WHEREAS, William and Allison Fleck are the owners of real property located at 31 Shadyside Avenue, Upper Grandview, New York 10960; and

WHEREAS, the owners intend to make improvements to their driveway; and

WHEREAS, said property is within the Critical Environmental Area, and in order to proceed, the owners have been required to seek site plan approval from the Town of Orangetown Planning Board; and

WHEREAS, the accompanying hold harmless has been reviewed and approved by the Town Attorney's Office; and

WHEREAS, the Town Attorney's Office and the Town of Orangetown Department of Environmental Management and Engineering (DEME) recommend accepting the accompanying hold harmless agreement, which has already been executed by the owners, and the original forwarded to the Town for execution by the Town.

NOW, THEREFORE, BE IT RESOLVED, that the Town hereby grants to 31 Shadyside Avenue, Upper Grandview, New York, license, in the form of a Covenant, Hold Harmless and Indemnification Agreement for said property to make improvements to the driveway in accordance with Planning Board Decision #21-30, which agreement provides, among other things, that the property owners hold the Town harmless for all damages that result from the Town Sewer Department repairing, replacing or digging up the Town-owned sanitary main located inside the Town's sanitary sewer easement on said property.
