APPROVE SEQRA DETERMINATION / TYPE II ACTION / TIER IV PUMPING STATION IMPROVEMENTS

WHEREAS, the Town of Orangetown Department of Environmental Management and Engineering has determined the need to improve and upgrade several existing sanitary pumping stations that have met their current service life and necessitate improvements; and,

WHEREAS, the State of New York, Environmental Facilities Corporation provides financial assistance to municipalities to upgrade waste water infrastructure through the New York State Water Infrastructure Improvement Act, Clean Water program for which the Town of Orangetown intends to submit an application for funding; and,

WHEREAS, the Town Board, with the assistance of the Department of Environmental Management and Engineering and Environmental Design & Research (EDR) of whom is the Town's engineering consultant for this project, has considered the proposed action in the light of the State Environmental Quality Control Act (SEQRA), and the implementing regulations adopted thereunder, and has concluded that the action consisting of the upgrading of said pumping stations as part of the Tier IV improvements, constitutes a Type II action under SEQRA in that the action involves "the replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site. . . ."

NOW, THEREFORE, BE IT RESOLVED, that the Town Board determines that the said action, as described, constitutes a Type II action under SEQRA meaning the proposed action will not have a significant impact on the environment, and no further action or review under SEQRA is required.

RESOLUTION NO. 411

OPPOSITION / NYS ASSEMBLY BILL A4854 /NYS SENATE BILL S4547 / PERMIT ACCESSORY DWELLING UNITS IN SINGLE-FAMILY RESIDENTIAL ZONES

WHEREAS, the New York State Assembly is considering a bill, identified as A4854, with corresponding legislation in the New York State Senate, identified as S4547 which mandate that local municipalities provide for accessory dwelling units in accordance with a proposed change to the New York Real Property Law, and that local municipalities must permit accessory dwelling units in all single-family residential zones, and

WHEREAS, the proposed legislation abrogates the rights of local municipalities established in the New York State Constitution to self-govern in areas related to zoning regulations, pursuant to the long-established Municipal Home Rule, where zoning is and always

has been a function of local municipalities and representatives elected by the persons who reside in the municipalities where they govern, and

WHEREAS, the Town of Orangetown already has local legislation, enacted in 1983, which allows for Restricted Two-Family Conversions upon meeting certain requirements set forth in the local law, and

WHEREAS, there are sustainability concerns with the mandate of such dense housing in areas zoned for single family dwellings, including but not limited to, water and sewer capacity, flooding issues, road maintenance and controls and police, and

WHEREAS, the proposed legislation is deficient in many respects, not the least of which are issues being ignored related to the State Environmental Quality Review Act (SEQRA), as well as issues related to fire safety and flooding concerns,

NOW THEREFORE BE IT RESOLVED, that the Town of Orangetown hereby expresses its opposition to the proposed legislation amending the New York Real Property Law addressing accessory dwelling units, and expresses its concern for the consideration of such legislation that is a clear violation of the New York State Constitution and the right of local municipalities to govern themselves, by representatives elected by persons living in their local community, pursuant to Municipal Home Rule, and

BE IT FURTHER RESOLVED, that the Town of Orangetown joins other local municipalities and State representatives in their opposition to this legislation as posing a danger to the health, safety and welfare of the very persons this legislation is purportedly designed to help, by authorizing the conversion of spaces that would pose a danger to fire safety, exposure to flooding and issues related to parking, traffic and overcrowding.
