RESOLUTION NO. 415

ADOPTION OF LOCAL LAW NO. <u>8</u> OF 2021 / AMENDING CHAPTER 5 (BUILDING CONSTRUCTION AND FIRE PREVENTION), SO AS TO ADOPT THE NYSTRETCH ENERGY CODE-2020

IT IS HEREBY RESOLVED, by the Town Board of the Town of Orangetown, as follows:

WHEREAS, to prevent a statewide patchwork of stricter energy codes, the New York State Energy Research and Development Authority (NYSERDA) developed the NYStretch Energy Code-2020 (NYStretch).

WHEREAS, a stretch energy code is simply an energy code that is more stringent than the minimum base energy code that can be voluntarily adopted by local jurisdictions. NYStretch is a model stretch code that will be ten to twelve percent (10-12 %) more efficient than the minimum requirements of the base energy code, the 2020 Energy Conservation Construction Code of New York State (2020 ECCCNYS).

RESOLUTION NO. 415 - Continued

WHEREAS, some New York State municipalities have adopted stricter energy standards to ensure reduced energy costs for its residents and businesses.

WHEREAS, under NYS Energy Law §11-109, the Town Board of The Town of Orangetown is authorized to adopt a local energy code more stringent that the 2020 ECCCNYS.

WHEREAS, the New York State Energy Research and Development Authority (NYSERDA) developed NYStretch as a statewide model code for New York jurisdictions to use to meet their energy and climate goals by accelerating the savings obtained through their local building energy codes; and, for jurisdictions that adopt it, NYStretch will provide savings of roughly 11% over the 2020 ECCCNYS when that energy code is released by the New York State Department of State.

WHEREAS, NYStretch is a stretch code that: (i) is readily adoptable with minimal changes by local governments; (ii) is in enforceable language; (iii) is coordinated with the New York State Uniform and Energy Codes; (iv) is about one cycle ahead of the next New York State Energy Code in its requirements; (v) lowers energy use and greenhouse gas emissions associated with new and existing buildings; and (vi) is cost-effective and regionally appropriate.

WHEREAS, the Town Board is considering amending provisions of Chapter 5 of the Code of the Town of Orangetown ("Orangetown Code"), entitled Building Construction and Fire Prevention, so as to add provisions for a local energy code.

WHEREAS, the Town Board is declared Lead Agency for the purposes of environmental review with respect to the proposed Resolution, in accordance with Article 8 of the Environmental Conservation Law of the State of New York, and the Regulations promulgated thereunder at 6 NYCRR 617 (collectively, the State Environmental Quality Review Act or SEQRA).

WHEREAS, the Town Board, as the SEQRA Lead Agency, has determined that the proposed Action meets the criteria of a Type II Action under SEQRA Regulation §617.5(c) (33), which is exempt from, and is not required to undergo, a SEQRA environmental review.

WHEREAS, the Town Board has determined that this proposed Local Law is not subject to the mandates of NYS General Municipal Law (GML) §239-m, and, therefore, not required to be referred to the Rockland County Planning Department for GML review.

WHEREAS, the Town Board has complied with all public notice requirements as mandated by New York State statute(s) and the Orangetown Code, and the proposed Local Law has been distributed to the Town Board as per NYS Municipal Home Rule Law §20(4), and a Public Hearing was duly held by the Town Board regarding the proposed Local Law on October 26, 2021, at which time all persons either for or against said amendments were heard.

NOW, THEREFORE, BASED ON ALL OF THE INFORMATION BEFORE THE TOWN BOARD, AND THE FINDINGS MADE HEREIN, BE IT RESOLVED that the Town Board hereby adopts and enacts the proposed Local Law in the form and substance, as may be amended herein, as set forth below.

TOWN OF ORANGETOWN LOCAL LAW NO. <u>8</u> OF 2021

AMENDMENTS TO CHAPTER 5 (BUILDING CONSTRUCTION AND FIRE PREVENTION) OF THE CODE OF THE TOWN OF ORANGETOWN / PROVISIONS FOR A LOCAL ENERGY CODE

Section 1. Legislative Intent

The Town Board of the Town of Orangetown (Orangetown) seeks to protect and promote the public health, safety, and welfare of its residents by mandating energy efficient building standards. On _____, 20___, the 2020 Energy Conservation Construction Code of New York State (ECCCNYS), updated by the New York State Fire Prevention and Building Code Council, became, or will become, effective and must be complied with for residential and commercial buildings unless a more restrictive energy code is voluntarily adopted by a local jurisdiction. In 2019, the New York State Energy Research and Development Authority (NYSERDA) developed and published the NYStretch Energy Code-2020 (NYStretch), a more energy efficient building code than the 2020 ECCCNYS. This proposed amendment to the Orangetown Code seeks to modify Chapter 5 of the Orangetown Code (Building Construction and Fire Prevention) so as to adopt NYStretch and to enact more restrictive regulations as they relate to new or substantially renovated buildings.

Section 2. Amendment

Section 5-1 of Chapter 5 (Building Construction and Fire Prevention) of the Orangetown Code shall be amended and, as amended, shall read as follows:

§5-1. Applicability of Uniform Code, Energy Code and NYStretch. The applicability of the New York State Uniform Fire Prevention and Building Code (Uniform Code), and the State Energy Conservation Construction Code (Energy Code), were accepted by Town of Orangetown Local Law No. 5 of 2017, adopted by the Town Board of the Town of Orangetown on May 16, 2017. The NYStretch Energy Code-2020, published by the New York State Energy Research and Development Authority, hereinafter referred to as "NYStretch," shall be applicable to all new construction, substantial renovations, alterations and additions within the Town of Orangetown, as required by the 2020 Energy Conservation Construction Code of New York State as amended by NYStretch.

Section 3. Authority

This proposed Local Law is enacted and adopted pursuant to NYS Energy Law §11-109(1), and NYS Municipal Home Rule Law §10, and in accordance with the procedures prescribed in NYS Municipal Home Rule §20.

Section 4. Severability

If any section, subdivision, paragraph, clause or phrase of this Local Law shall be adjudged invalid, or held to be unconstitutional, by any court of competent jurisdiction, any judgment or order made thereby shall not affect the validity of this Local Law as a whole, or any part thereof, other than the part or provision so adjudged to be invalid or unconstitutional.

Section 6. Effective Date

This Local Law shall take effect upon publishing and posting a copy in the manner prescribed by applicable laws, and upon filing a copy with the NYS Secretary of State.

AUTHORIZE AGREEMENT WITH LANDSCAPE STRUCTURES, INC. / VETERANS PARK PLAYGROUND

WHEREAS, pursuant to Town Board Resolutions 2020-107 and 2020-342 the Town Board agreed to accept grants totaling \$500,000.00 from the New York State and Municipal Facilities Program (SAM) to be administered by the Dormitory Authority of the State of New York (DASNY) for construction of a playground at Veterans Memorial Park, and

WHEREAS, pursuant to General Municipal Law § 103(16), a municipality is authorized to make purchases of apparatus, materials, equipment and supplies, or to contract for services related to the installation of apparatus, as required, through the use of a contract let by the United States, or any agency thereof, or any state or any other political subdivision or district therein, if such contract was let to the lowest responsible bidder or on the basis of best value, in a manner consistent with GML § 103 and specifically made available to other municipalities; and

WHEREAS, Sourcewell, formerly known as the National Joint Powers Alliance ("NJPA"), is a public entity whose creation was authorized by the State of Minnesota, pursuant to Minn. Stat. § 123A.21; and

WHEREAS, Sourcewell is permitted to engage in cooperative purchasing, pursuant to Minn. Stat. § 471.345, for supplies, materials and equipment based on sealed competitive bid, direct negotiation or best value, based on the estimated cost of the item; and

WHEREAS, in or about November, 2020 Sourcewell, issued a Request for Proposal for the procurement of playground and water play equipment with related accessories, which proposals were due, received and opened publicly on January 5, 2021; and
