Chapter 12 of the Code of the Town of Orangetown, Section 12-4 (A), Historical Areas Board of Review. Tax Map Designation: 77.15 / 1 / 54; R-15 zoning district.

Heard by the HISTORICAL AREAS BOARD OF REVIEW at meetings held on the following Tuesdays, February 8, 2022 and February 15, 2022 at which time the Board made the following determination:

Harry Perez appeared at the February 8, 2022 hearing and there was not a quorum.

The Board agreed to have a special meeting to accommodate the applicant on February 15, 2022 and it was announced at the hearing.

At the February 15, 2022 hearing Harry Perez appeared.

The following documents were presented:

1. A copy of the plot plan, bulk table and elevations of the proposed addition by Harry Goldstein, Architect.

Harry Perez stated that he would like to thank the Board for having this special meeting; that he and his wife purchased the house in 2015 and when they moved here, they had one daughter a year old; that they love the house and the neighborhood; that they are the house right door to the De Wint House and they have been friends with Mr. and Mrs. Jones, the grounds keepers, since moving in; that they just added to the family in November; that they are proposing to add a family room to the rear of the house and enlarge the kitchen; that their family is from New York City and they would like a larger space to host; that the gutters & leaders will match existing; that there will be one lantern outside the sliding door in the back; and that the roof, siding and windows will match the existing house.

Margaret Raso asked about the lighting and gutters and leaders. William Walther asked if the roof, siding and windows would match existing.

- 3. The soffits and fascia shall vinyl/aluminum Certainteed Colonial White.
- 4. The gutters and leaders shall white aluminum.
- 5. The windows shall be white vinyl and wood Anderson Series 400.
- 6. The trim shall be white.
- 7. The back door shall be a white vinyl/wood Anderson 400 series glider.
- 8. The shall a single coach light by the sliding glass door in the rear of the house.
