After said date, 1% for each month or part thereof until date of return of unpaid taxes is made by the Town Clerk to the Commissioner of Finance pursuant to the law.

The installment option plan (4 installments) is available when paying your County/Town Tax. If you elect to pay by installments, a 5% County Service Charge will be added to the total tax. The first installment must be received by my office by January 31, 2024 and all remaining installment payments must be made payable and forwarded to the Rockland County Commissioner of Finance.

Your Property tax savings this year resulting from the State Citizen Empowerment Tax Credit received as the result of local government re-organization is 1.68% of the Town Budget.
