
Jose Garcia and John Matthews appeared and testified. The Board received the following items:

RE: St. Thomas Aquinas College Sign Plan: The application of John Atzl, applicant for St. Thomas Aquinas College, owner, for Review of a Sign Plan at a site to be known as "St. Thomas Aquinas College Sign Plan", in accordance with Article 16 of the Town Law of the State of New York and Chapter 2 of the Code of the Town of Orangetown. The site is located at 125 Route 340, Sparkill, Town of Orangetown, Rockland County, New York, and as shown on the Orangetown Tax Map as Section 74.12, Block 1, Lot 29 in the R-40 zoning district.

Heard by the Architecture and Community Appearance Board of Review of the Town of Orangetown at a meeting held **Thursday**, **June 2**, **2022**, at which time the Board made the following determinations:

A. Project Package that included the following item:



C. Copy of the ZBA Decision, ZBA#22-28, Signage Variance Approved, dated May 4, 2022.

FINDINGS OF FACT:

- 1. The Board found that the applicant proposed to place signs on the campus buildings, identifying the building's name. Twelve signs are proposed, all are constructed out of individual cast aluminum letters, painted satin white, as noted on the submitted plans.
- 2. The Board found that the proposed signs would be Ariel Bold font. One sign would be visible from Route 340, the "Saint Thomas Aquinas College" sign. This sign would have 42-inch letters and would have uplighting. The Board requested that this sign be placed on a timer to go off no later than 1:00 a.m.

3. The Board found that 10 signs would have 12-inch lettering and one sign would have 8-inch lettering. The font of the lettering is similar to other fonts used on the Saint Thomas Aquinas College Campus.
