# RESOLUTION NO. 474 AUTHORIZE AMENDED EASEMENT / HOLD HARMLESS AGREEMENT / SANITARY SEWER / BARTELS PROPERTY / 15 ORCHARD STREET NYACK

WHEREAS, Maryann Bartels is the owner and resident of the property located at 15 Orchard Street, Nyack New York, tax lot 66.22/2/14, and

WHEREAS, the Town, through the Village of Nyack, has an easement across the aforesaid property for sanitary sewer purposes, which easement is identified in Map 360 that was filed on April 25, 1939 in the Rockland County Clerk's Office, and


