Summary of Public Comments:

Kevin Clancy & Sandra Eubanks, Orangeburg, complained that the single-family residence at 19 Carlton Rd, is a boarding house. They requested the Regulations / Town Code as to what the owners are allowed to do and they requested the Town to look into this matter.

Jamie Failing, Cathy Cawley, Robert Beers, & Greg Winsko, Pearl River; John Sherry, W. Nyack; and Patricia DeGraw, Blauvelt, are in favor of Rockland Cider Works (RCWS). They hope all parties will make a fair agreement and concessions. Something needs to be worked out. Patricia DeGraw suggested: all violations should be made public and "No Parking" signs be installed on Sickletown Road.

Darin Van Houten, Owner of Rockland Cider Works, spoke about agriculture and tourism. He wants to work with the Town to save the farm and RCWS. He would like to set a date for a meeting with the Town Supervisor.

Loretta Tito & Jerry Goggins, Orangeburg; and Kevin Mc Cormack, Pearl River; likes the farm but not RCWS. They complained about the parking and dangerous possible fire conditions. Barbara Delo, Blauvelt, is opposed to the draft Comprehensive Plan. The plan needs to have substantial changes.

Eileen Larkin, Palisades, encourage the Town Board to approve a senior citizen tax exemption income increase.

RESOLUTION NO. 543

AUTHORIZE / SELL PARK LAND AND GRANT TEMPORARY EASEMENT TO COUNTY OF ROCKLAND / VICINITY OF THE WEST WASHINGTON AVENUE BRIDGE IN PEARL RIVER

WHEREAS, the County of Rockland is proceeding with plans for a project to replace the West Washington Avenue Bridge over the Pascack Brook and realign West Washington Avenue in Pearl River, Town of Orangetown; and

WHEREAS, the Town of Orangetown is the owner of certain property located in the vicinity of the West Washington Avenue Bridge and which property is currently used by the Town of Orangetown as park land; and

WHEREAS, the County of Rockland is seeking to acquire such Town owned park land for purposes of completing roadway safety improvements including replacement of the bridge at that; and

WHEREAS, pursuant to Town Board Resolution 2021-235 which is incorporated by reference herein, the Town Board approved the submission of a Home Rule Request for the enactment of special state legislation, Bill S5953A in the senate, and Bill A 6745A in the Assembly, authorizing the Town to discontinue the use of the Town parkland in the vicinity of the West Washington Avenue Bridge; and

WHEREAS, the State of New York approved and authorized the alienation of this parkland pursuant to New York Session Law Chapter 576 of 2021, under the terms and conditions set forth more fully therein; and

WHEREAS, pursuant to an appraisal obtained by the County of Rockland, and reviewed by the Town, the appraised value of the property that is to be permanently transferred by the

Town to the County is \$114,620.00, and the value of the property that is subject to a temporary easement grant by the Town to the County is \$27,080.00, for a total price of \$141,700.00; and

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Orangetown hereby approves the transfer and sale of the Town owned park land property in the vicinity of the West Washington Avenue Bridge, Pearl River, that being a 39,525.00± Square Foot parcel located along the northern side of West Washington Avenue, and authorizes the grant of a temporary easement over a 31,129.00± Square Foot parcel for three (3) years, as more fully described and set forth in the attached agreement with the County of Rockland, upon receipt of a total payment of \$141,700.00 (One Hundred Forty One Thousand Seven Hundred Dollars) from the County of Rockland, which funds shall be used towards the acquisition of new parklands and/or capital improvements to existing park and recreational facilities that are owned and operated by the Town; and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized to sign the Agreement with the County and any and all documents necessary to effectuate the transfer of the property and grant of easement that may be necessary to effectuate the purposes of this resolution, upon review and approval of the Town Attorney; and

BE IT FURTHER RESOLVED, that as this resolution authorizes the conveyance and temporary encumbrance of real property owned by the Town, that this resolution is subject to permissive referendum pursuant to §64(2) and §90 of the New York Town Law.

RESOLUTION NO. 544

APPROVE / AGREEMENT / EVCONNECT / DEPOT SQUARE, SPARKILL CHARGING STATIONS / 5 YEARS

WHEREAS, in 2018, the New York Power Authority ("NYPA") contracted on the Town of Orangetown's behalf with EVConnect to purchase a software subscription for the electric vehicle charging stations in Depot Square, Sparkill for 4 years; and,

WHEREAS, the contract with NYPA and EVConnect will end on November 30, 2022 for the Depot Square, Sparkill charging stations; and,

WHEREAS, EVConnect has a contract with Sourcewell for electric vehicle charging station software and the Town may, pursuant to Chapter 1A of the Town Code and New York General Municipal Law §103(16), enter into a contract with EVConnect as part of the Sourcewell Contract #042221-EVC; and,

NOW, THEREFORE BE IT RESOLVED, upon the recommendation of the Supervisor's Office, the Town Board hereby approves to enter into a 5-year contract with EVConnect for the Operate software subscription, not to exceed \$3,500, to be paid from the following budget line item SP 3320.457; and,

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized to sign the agreement with EVConnect, subject to review and approval of the Town Attorney.

WHEREAS; Chapter 39, Article III; Section 39-25 of the Town Code finds that the leaving of vehicles on designated Town highways during periods of heavy snowfall has hindered and obstructed the Department of Highways in snow removal operations, and that the leaving of vehicles on designated Town highways during snowfalls causes hazards to persons using such highways, and that the purpose of this local law is to protect the health, safety and well-being of persons and property by imposing restrictions on the leaving of vehicles on designated Town highways during periods of heavy snowfall, and

WHEREAS, upon the dissolution of the former Village of South Nyack, certain roads that were not part of the Town roads to which that section was applicable are now the responsibility of the Town,

NOW THEREFORE, BE IT RESOLVED; the following roads in the hamlet of South Nyack shall be designated Emergency Routes as per section 39-27, "Emergency Routes," and the Town board hereby authorizes the Superintendent of Highways to place Emergency Route Signs at these road locations:
