Barbara Delo, Blauvelt, is against this plan. Most of the plan is pushing for multi-family housing. Eileen Larkin, Palisades, believes the Governor will challenge our Comprehensive Plan. She wants to see affordable senior housing and she believes we need to repurpose empty buildings. Mike Mandel, Pearl River, is concerned about the Governor's plans regarding Transit Development Housing, High Density Housing and EV batteries.

Jeff McCall, Nyack, presented and read his letter regarding the Senior Citizens' Clubs (Exhibit 01-24-B).

Kevin McCormack, Orangeburg, said RCW is not a good neighbor and is concerned about their unsafe activities in a residential neighborhood. He asked about the zone change.

Eileen Larkin, Palisades, is concerned that the public hearing regarding the increase of the income level will be too late. Senior Citizens need tax relief.

Gerry Goggins, Orangeburg, informed the Town Board of some of the rulings regarding RCW. Barbara Delo, Blauvelt, gave her thoughts on development in Orangetown, such as, affordable housing for younger people and senior citizens.

Susan McWhinny, Orangeburg, requested the Town Board to hold-off on Referring the RCW petition to the LaBerge Group for review.

Summary of Public Comments - Continued

Joyce Taub, W. Nyack, said RCW has broken Town laws, operating illegality and she is against the LaBerge Group reviewing their petition.

Alex Shah, attorney representing RCW's neighbors, is against the LaBerge Group reviewing RCW's petition and said Town Board members with a conflict must recuse themselves. Darin Van Houten, owner of RCW, spoke about the gross mischaracterizations, and said the rulings are blizzard and there is nothing stopping from the Town & RCW working together. Robert Zitl, attorney for the RCW's neighbors, said it's a simple decision for the Town Board. The Town and NYS court have determined, RCW is not operating within its description. Stuart & Carolynn Rasch, Pearl River, submitted a letter regarding RCW (Exhibit 01-24-B). Eric Hofia, Piermont, complained about a lot of trash along the roads and that the recyclable bins are too small. He suggested strong worded signs and cameras for littering.

WHEREAS, in order to realize this vision, the Town, in cooperation with HNA, issued a Request for Expressions of Interest ("RFEI"), identified Reveil LLC ("Reveil") as its Preferred Developer and entered into a Memorandum of Understanding ("MOU") with Reveil for the development of the Property; and

WHEREAS, in addition to the numerous violations and blighted condition of the Property, HNA is currently in tax arrears of over \$4,000,000.00; and

WHEREAS, with the assistance of the Town, on or about April 28, 2022, HNA entered into a Letter of Intent ("LOI") with Reveil, which set forth the terms pursuant to which, among other things, Reveil would hopefully enter into a consensual Purchase and Sale Agreement with HNA ("PSA") to sell the Property to Reveil; and

**WHEREAS**, in connection with the execution of the LOI, Reveil made a \$200,000.00 deposit;

WHEREAS, since entering into the LOI, Reveil has proceeded in good faith to negotiate and consummate the PSA with HNA; and

WHEREAS, On October 7, 2022, Reveil executed the PSA and delivered signature pages to its counsel to hold pending execution by HNA, and posted an additional \$400,000.00 deposit with the Escrow Agent, bringing Reveil's total deposit amount to \$600,000.00; and

WHEREAS, despite Reveil's signing of the PSA and depositing \$600,000.00 with the Escrow Agent, HNA has failed to execute the PSA; and

#### **RE: COMPREHENSIVE PLAN PUBLIC COMMENT INPUT**

Below are comments to certain information currently shown in the December 2022 draft Comprehensive Plan. Two significant comments further described below include:

- There are some important steps the Town Council may take within the Comprehensive Plan to protect Parkland and the residential community from Heavy Trucking that is prohibited on Oak Tree Road, Kings Highway, Campbell Ave and William St. The Town of Orangetown should closely monitor and protest any NYSDOT redesign/repaving of NY Route 340 that is not consistent with residential use, including dense neighborhoods.
- The Parkland Inventory is very impressive, we are very fortunate and all efforts to protect
  and preserve open space and parkland is of interest to all. Sparkill Memorial Part consists
  of three separate parcels of parkland that warrant individual listings instead of one listing
  shown in the draft plan table item #35 labeled "Sparkill Memorial Park."

Finally, an architect prepared new Sparkill Memorial Park conceptual designs and numerous public meetings were held to narrow the design alternative down to five. We now have seen firsthand the importance of having recreational and social access points during the COVID pandemic, and residents flocked to the Joseph Clarke Rail Trail and Sparkill Memorial Park.

Please consider including these designs in the Comprehensive Plan. To further protect parkland, please consider changing the name "Depot Square" to "Depot Park." These two changes are relatively easy to include in the plan and represent Orangetown's interest to preserve and protect cultural and recreational assets that directly impact our quality of life everyday.



- 1. The paragraph titled "<u>US Route 9W and New York State Route 340 Repaying</u>" states Route 340 is in the NYSDOT planning stages of being "repayed" from the New Jersey State Line all the way to NY State Route 303. Recognizing the risk of the NYSDOT applying a design that provides for heavy trucking in industrial centers (instead of a design which serves residential neighborhoods having complementing characteristics consistent with a residential single lane roadway) the Comprehensive Plan as next steps should state *Orangetown needs to be involved with the NYSDOT on this project to ensure it is not engineered and designed as a HEAVILY TRAVELED TRUCK ROUTE, but appropriately as a residential single lane roadway one would expect in a residential neighborhood.*
- 2. The transportation highway map incorrectly displays a red-square in the downtown hamlet of Sparkill signifying a "park & ride." At this location is Sparkill Memorial Park, a 1.2 acre parcel (77.08-4-28) consisting of asphalt pavement and the "sparkill green" on which several historical markers reside. At either end are two separate parks, namely, the DiFrancesca Memorial Park (77.08-04-29) and a Unnamed Park (77.08-04-28), that until 2007 was unlined/unmarked asphalt.
- 3. The Parkland Inventory Table item # 35 titled "Sparkill Memorial Park" should list three separate parks, namely: Sparkill Memorial Park (77.08-4-28); DeFrancesca Memorial Park (77.08-04-29) and; Unnamed Parkland (77.08-04-28).
- 4. The map displaying spheres indicating the 10-minute walking radius to town centers needs a sphere centered at the intersection of Main St and Union St Sparkill. It currently is malpositioned and bisected by the Palisades Parkway.
- 5. The Legend shown in the zoning map has at least one incorrect Label. The Legend displaying the Orange area should be titled "Sparkill Hamlet Center Overlay."
- 6. The draft comprehensive plan mentions the NYSDEC Flood Mitigation and Resiliency Report (SD115) but falls short of identifying two important solutions "to guide the implementation of mitigation projects" in Orangetown. The DEC recommends (Sections 4.1 4.2) the Replacement of the Williams Street Bridge with a Span of 60 feet and; the removal of the Boss Pond Dam. It would be very beneficial if the above specific DEC recommended mitigation projects were included in the Plan, especially since these two projects would protect the Sparkill Fire Department, a critical first responder facility abutting the Sparkill Creek.



Recognizing the risk of the NYSDOT applying a design that provides for heavy trucking in industrial centers (instead of a design which serves residential neighborhoods having complementing characteristics consistent with a residential single lane roadway) the Comprehensive Plan as next steps should state Orangetown needs to be involved with the NYSDOT on this project to ensure it is not engineered and designed as a HEAVILY TRAVELED TRUCK ROUTE, but appropriately as a residential single lane roadway one would expect in a residential neighborhood.
- 2. The transportation highway map incorrectly displays a red-square in the downtown hamlet of Sparkill signifying a "park & ride." At this location is Sparkill Memorial Park, a 1.2 acre parcel (77.08-4-28) consisting of asphalt pavement and the "sparkill green" on which several historical markers reside. At either end are two separate parks, namely, the DiFrancesca Memorial Park (77.08-04-29) and a Unnamed Park (77.08-04-28), that until 2007 was unlined/unmarked asphalt.
- 3. The Parkland Inventory Table item # 35 titled "Sparkill Memorial Park" should list three separate parks, namely: Sparkill Memorial Park (77.08-4-28); DeFrancesca Memorial Park (77.08-04-29) and; Unnamed Parkland (77.08-04-28).
- 4. The map displaying spheres indicating the 10-minute walking radius to town centers needs a sphere centered at the intersection of Main St and Union St Sparkill. It currently is malpositioned and bisected by the Palisades Parkway.
- 5. The Legend shown in the zoning map has at least one incorrect Label. The Legend displaying the Orange area should be titled "Sparkill Hamlet Center Overlay."
- 6. The draft comprehensive plan mentions the NYSDEC Flood Mitigation and Resiliency Report (SD115) but falls short of identifying two important solutions "to guide the implementation of mitigation projects" in Orangetown. The DEC recommends (Sections 4.1 4.2) the Replacement of the Williams Street Bridge with a Span of 60 feet and; the removal of the Boss Pond Dam. It would be very beneficial if the above specific DEC recommended mitigation projects were included in the Plan, especially since these two projects would protect the Sparkill Fire Department, a critical first responder facility abutting the Sparkill Creek.



Members of the Town Board,

I am appearing tonight to object to the funding of the \$6,500.00 hereinabove referred to. The "Appointed Officials" are members of the Orangetown Senior Citizen Clubs, one from each club is to be appointed and to serve on the Senior Citizens Advisory Committee. A Senior Leader is also an appointed Official.

The members of the Committee, the Senior Leader and officers from the seven (7) senior citizen clubs meet monthly except for July and August, 10 meetings. The topic most discussed at the meetings are the trips the clubs went on or are to go on. Meetings last from 1 to 1.5 hours.

I believe, but have not been able to verify, that the \$6,500.00 in the past has only been paid to the Senior Leader. The budget sets forth "Appointed Officials", plural which in my opinion would include the other appointed officials which are the seven (7) members of the Committee.

In my opinion the \$6,500.00 should be added to the \$185,000.00 also set forth in Item 6772 which is allocated to the seven (7) senior citizen clubs for trips and activities for ALL the senior citizen members in the clubs.

There are seven (7) clubs; there are four (4) officers per club; there are trip coordinators in each club usually and other senior members that volunteer for duties in their clubs which is a total of approximately 40 to 45 seniors who VOLUNTEER their time and efforts to their clubs WITHOUT COMPENSATION.

If the \$6,500.00 is restricted by the 2023 budget to the "Appointed Officials" so be it. However, same should be paid to the Seven (7) members of the Committee and the Senior Leader, 1/8th to each not all to one. I hope that the 2024 budget removes the \$6,500.00 for Appointed Officials and adds same to the Club members for a total of \$101.500 mbs canish to the Club monies for a total of \$191,500 The senior citizens who work as uncompensated volunteers do not look upon their efforts as a job but as a calling to help their fellow seniors.

I am writing this letter en leu of speaking at the town board meeting 24 January 2023, as I will be out of the country.

I am concerned with the current proposal of deferring the judgement of the town board to the Laberge Group regarding changes and amendment to the zoning for the above captioned property.

The Petitioner, Rockland Cider Works (RCW) has had a history of supplying incomplete and inaccurate information regarding its applications for permits under its current zoning. They have pre-ported to be a farm, however they do not grow or produce any products at this location. They have used this claim in the application to the State Liquor Board in order to obtain the permits to sell spirits. They have failed to comply with fire code, and building code in the past, yet act as if they are above the law.

As a resident and as a neighbor of the property my main concern is for safety and security of the environment. The property abuts a watershed, and a reservoir, which supplies drinking water to Rockland and Northern New Jersey, and SCS Engineers, New York, in Suffern seems much more capable of providing an Environmental Impact statement for the proposed zoning change.

This change should not allow an open bar/restaurant/entertainment venue to operate in a residential area, without noise abatement, sewer and drainage and capacity limitations being firmly addressed and adhered to by the applicant. These issues should be addressed prior to any site visit or engineering plan or proposal for change in the zoning regulations. Additionally it is my concern that once any change in the zoning regulation is made, subsequent owners of the property may expand the venue as the contracts with current users expire.

It is my understanding that two current members of the board, Mr. Diviny and Mr. Valentine have done work for the property owners, and this appears to be a prima facia conflict of interest. I am interested in what guideline are in place to prevent these confects.
