Rick Tannenbaum, Executive Director of Hi-Tor Animal Shelter, spoke about all the material changes and improvements made at the shelter. He also invited the Town Board to visit and solicited the Town's business back to the shelter.

Gerry Goggin, Orangeburg, believes the report/proposal from Laberge Group is inaccurate. He gave his opinion of the first page of the report.

Joyce Taub, Orangeburg, is against RCW. This residential area is the wrong place for RCW. RCW should work within existing municipal zoning laws.

Sharon Van Houten, Orangeburg, clarified that RCW is not located on 7.1 acres; they only have 6.1 acres. She does not support any re-zoning or special permits. This property should not be rezone, changed or used until the existing court case is settled, which is not going to be anytime soon.

Susan McWhinney, Orangeburg, explained that RCW is not a working farm. She pointed out errors in RCW's public campaign and gave a history of Van Houten Farm and RCW.




