WHEREAS, the Town Board has considered the adoption of an amendment to Chapter 43, § 2.2, of the Town Code, establishing the Town Zoning Map, to change the zoning classification of the parcel known as 175 East Washington Avenue in the hamlet of Pearl River, tax lot Section 68.16 Block 5 Lot 56 from "CC" to "RG", and

WHEREAS, on or about, pursuant to Town Board Resolution 2023-211 the Town Board circulated amongst various potential interested agencies notice of its intention to assume Lead Agency status for the purpose of the environmental review of the above referenced action; and

WHEREAS, being the only Involved Agency, the Town Board hereby assumes the role of Lead Agency for environmental review; and

WHEREAS, acting in its capacity as Lead Agency for environmental review, and after taking a "hard look" at all of the potential environmental impacts that might result from the proposed action, the Town Board has concluded that there will be no significant environmental impact or effect caused or occasioned by the proposed change in the zoning classification of the subject parcel affected by the proposed Local Law,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby adopts the Negative Declaration annexed hereto, and authorizes the Town Supervisor or her designated agent to execute the Environmental Assessment Form and to take such other and further steps as may be necessary to discharge the Town Board's responsibilities as Lead Agency.

ADOPT LOCAL LAW 4, 2023 / PROPOSED ZONE CHANGE FOR 175 EAST WASHINGTON AVENUE, PEARL RIVER, NY.

WHEREAS, the Town Board of the Town of Orangetown (the "Town Board") is the duly elected legislative body of the Town, authorized to adopt zoning text amendments to the Town's Zoning Law; and

RESOLUTION NO. 283 - Continued

WHEREAS, the Town Board has considered the adoption of an amendment to Chapter 43, § 2.2 to change the zoning district of the parcel known as 175 East Washington Avenue in the hamlet of Pearl River, tax lot 68.16/5/56 being located in the "CC" (Retail-Commerce) zoning district, to change the zoning classification of the property to that of "RG" (General Residence), a zoning district that already directly abuts the property, and

WHEREAS, by Resolution No. 211 of 2023, after notice duly given, and there being no other involved agency, by resolution duly adopted this 23rd day of May, 2023, the Town Board assumed the role of Lead Agency under SEQRA for environmental review, and, acting in its capacity as such, concluded that there will be no significant environmental impact or effect caused or occasioned by the proposed change in the Town's Zoning Law and determined the issuance of Negative Declaration is appropriate; and

WHEREAS, following due notice, a public hearing was conducted on the proposed zone change amendment; and

WHEREAS, the Board has concluded that the proposed zone change which changes the zoning classification of the subject parcel to a zoning district which already abuts the parcel due to a previous zone change, is consistent with the Town's Comprehensive Plan wherein it indicates on page IV-2 that "encouraging additional residential uses along this roadway (Middletown Road) would also be beneficial, strengthening the roadway's mixed-use character", and the subject property is two parcels away from Middletown Road, and otherwise is in the best interests of the Town and the owner of the parcel, who has requested the change of zoning classification; and

WHEREAS, the Town Planning Board, pursuant to Town Code Chapter 43, § 10.5, and the County Planning Department, pursuant to General Municipal Law §§ 239 l & m, have each reviewed the proposed law; and

WHEREAS, the Town Planning Board, by Memorandum, dated May 11, 2023, following due consideration at a public meeting held on the same date, has indicated that it does not object to the Town Board serving as Lead Agency on the matter and otherwise had no comment on the proposed action by the Town Board, and

WHEREAS, the Town Board finds that amending the zoning classification of this property will not have a significant impact on traffic or emergency services in the area, . and

WHEREAS, the County Department of Planning, as part of the General Municipal Law 239 (l) and (m) review, by letter review dated May 2, 2023, has recommended the petition for the zone change be approved,

NOW, THEREFORE, BASED ON ALL OF THE INFORMATION BEFORE THE BOARD, AND THE FINDINGS MADE HEREIN, BE IT RESOLVED, that the Town Board hereby adopts the within Local Law, amending the Town Zoning Law, and the Town Zoning Map made a part of the Town Code at Chapter 43, § 2.2., and changes the zoning classification of the referenced parcel known as 175 East Washington Avenue Pearl River, New York, tax lot 68.16/5/56 from "CC" to "RG".

RESOLUTION NO. 288

OPPOSING THE DISCHARGE OF CONTAMINATED WATER FROM INDIAN POINT INTO THE HUDSON RIVER AND URGING THE NYS LEGISLATURE TO SUPPORT S.6893 AND A.7208 AMENDING THE ENVIRONMENTAL CONSERVATION LAW IN RELATION TO THE DISCHARGE OF ANY RADIOLOGICAL AGENT INTO THE HUDSON RIVER

WHEREAS, the company decommissioning the Indian Point nuclear power plant has announced its intention to release water from onsite radioactive fuel waste pools into the Hudson River; and

WHEREAS, to date there has been no specific reporting of the radionuclide contents of this water which is heavily contaminated from the storage of the nuclear fuel waste; and

WHEREAS, pre-release filtration to remove these isotopes has been presented as a solution to reduce the content of these carcinogenic contaminants to a level "as low as reasonably achievable;" and

WHEREAS, the National Academy of Science has indicated that there is no verifiable safe level of these isotopes when they are ingested or inhale and such pre-release treatment would not remove tritium, also carcinogenic, from the water; and

WHEREAS, any contaminants in the Hudson present the risk of entering the food chain; and

WHEREAS, there are community members who depend on fish from the river as a food source, and in addition, there are seven communities upriver who source their drinking water from the Hudson; and

WHEREAS, since the river is an estuary that flows from south to north as well as from north to south, this fact must be considered; and

WHEREAS, the river also serves as a source of recreational activities and represents an economic resource that will be endangered by this reckless action; and

WHEREAS, New York Senate bill S.6893 and New York State Assembly bill A.7208 have been introduced, an act to amend the Environmental Conservation Law to prohibit the discharge of any radiological agent into the Hudson River; and

NOW THEREFORE, BE IT RESOLVED, that the Orangetown Town Board hereby strongly opposes the plan to release over a million gallons of contaminated water from the Indian Point Nuclear Power Plant site into the Hudson River; and

BE IT FURTHER RESOLVED, that the Orangetown Town Board hereby urges the New York State Senate to pass S.6893 and the New York State Assembly to pass A.7208 - an act to amend the Environmental Conservation Law to prohibit the discharge of any radiological agent into the Hudson River and urges the governor to sign such legislation; and

BE IT FURTHER RESOLVED, that the Clerk to the Town Board is hereby authorized and directed to send a certified copy of this resolution to the Hon. Kathy Hochul, Governor of the State of New York; Hon. Bill Weber, New York State Senator; Hon. John W. McGowan, Member of the New York State Assembly; the President Pro Tempore of the New York State Senate; the Speaker of the New York State Assembly; the Majority and Minority Leaders of the New York State Senate and Assembly; the New York State Public Service Commission, the New York State Department of Environmental Conservation, the Indian Point Decommissioning Oversight Board; and to such other persons as the Clerk in her discretion may deem proper in order to effectuate the purpose of this resolution.


