FINDINGS OF FACT:

1. The Board found that the properties consist of three buildings with residential apartment units. The applicant is seeking to modernize the building by adding vinyl siding and window trim with a green and white color scheme to the exterior. No other changes would be made to the building at this time. The Board found that no new landscaping would be added to the site.

- 2. The Board found that the applicant proposed to improve the façade as follows:
 - a. All windows and doors would be wrapped in Brown aluminum coil, (rather than black, as originally proposed).
 - b. Under the covered entry, 3 spots lights would be added and the old soffit would be replaced with new soffit.
 - c. In the areas where there is one window on the top of the other, the siding will be replaced with green board and batten vertical siding.
 - d. The porch columns and the base will be wrapped in Brown aluminum coil and the railings would be painted Brown, not black as originally proposed.
 - e. There would be new wall mounted LED light fixtures, one at each side of entry door in a silver finish.
 - f. The roof material would be tan/brown color

The hearing was then opened to the Public.

There being no one else to be heard from the public, the Public Hearing portion of the meeting was closed.

- 3. The Board found that the house would have four sides of vinyl siding manufactured by Georgia Pacific, or equal, in Bayou color. The house would have white Facia.
- 4. The Board found that the existing landscaping on the site to be acceptable.
