HABR#23-18: Application of Port Mackall, LLC for review of windows of an existing single-family residence at 143 Washington Spring Road, Palisades, New York. Chapter 12 of the Code of the Town of Orangetown, Section 12-4 (A). Historical Areas Board of Review. Tax Map Designation: 78.18 / 2 / 6; R-40 zoning district.

Heard by the HISTORICAL AREAS BOARD OF REVIEW at a meeting held on Tuesday, December 12, 2023 at which time the Board made the following determination:

Paul Sorvino and Richard Ellis, Real Estate Agent, appeared.

The following documents were presented:

- 1. Copy of a plot plan.
- 2. Copy of house elevations with windows colored that will be replaced and where there will be new Muntins.
- 3. HABR Decision #04-19 for an addition to the house and HABR#05-14 for the greenhouse and HABR#04-09 for an addition and alteration to the house..

Paul Sorvino stated that Eugene is out of town and he is present to speak about the windows at 143 Washington Spring Road; that they purchased the property two years ago; that some of the windows had already been replace with vinyl windows and some of the original windows from 1922 still existed, but all of the windows were leaking badly; that the original windows were 3 over 1 and they copied that style throughout the house; and he submitted pictures of the house and windows.

The Board members were looking at the pictures submitted and asked if the dividers were wood and if they were applied to the outside of the windows or the interior; that some of the pictures looked like they were applied on the inside and some on the outside.

At that time Paul called Eugen Cohen and he verified that the wood inserts were applied on both the interior and exterior window panes.

Loren Plotkin stated that the Board has no jurisdiction over the interior of the house.

William Walther agreed and stated that he was pleased that the wood muntins were applied on both interior and exterior.

Richard Ellis, Real Estate Agent, stated that he is certain that the divided light application was applied on the interior and exterior.
