- **B.** Architectural Plans prepared by Harry Goldstein, RA, dated August 12, 2021; Drawings 1 through 3.
- C. Material Specification Sheet and Project Narrative prepared by Applicant.
- **D.** A copy of the Building Permit Referral prepared by Rick Oliver, Deputy Building Inspector.

FINDINGS OF FACT:

- 1. The Board found that the site consisted of two lots that were merged to create one lot. The applicant obtained a Zoning Variance and is now appearing at ACABOR.
- 2. The Board found that four sides of the house would be vinyl siding in Flint color, manufactured by Georgia Pacific Double 5-inch Lap Siding, or equal. The roof shingles would be Pewter, manufactured by Timberline, or equal. The Board granted the applicant the option of using stonework on the house, as noted on the plan. The stonework would be El Dorado Mezzafield Light, or equal.

- 3. The Board found that the air conditioning unit would be placed on the left side of the garage. Lighting would consist of LED wall light fixtures above the garage door, front door and rear sliding glass door.
- **4.** The Board found that there would be no additional tree plantings on the site.
- **5.** Trees to be saved shall be protected with snow fencing to the drip line during construction.
- **6.** No grading is to take place within five feet of any property line, except as specified on the approved site plan.

The hearing was then opened to the Public.
