Item: *Proposed Local Law - Accessory Structures (GML-25-0278)*

Local law to amend Chapter 43, Article V (Additional Bulk Regulations) concerning setbacks and exceptions for accessory structures.
Throughout the Town

Reason for Referral:

County Highways, County Facilities, County Regulated Streams, County Parks, DEC Piermont Recreational Area, Long Path Hiking Trail, State Highways, State Facilities, NYS Thruway, State Parks, Towns of Clarkstown and Ramapo, Villages of Chestnut Ridge, Grand View-on-Hudson, Nyack, and Piermont, Palisades Interstate Parkway

The County of Rockland Department of Planning has reviewed the above item. Acting under the terms of the above GML powers and those vested by the County of Rockland Charter, I, the Commissioner of Planning, hereby:

Recommend the Following Modifications

- 1 Section 5.227 originally states that a portable building not over 144 square feet shall be permitted no closer than five feet to any property line, while the amendment proposes to reduce this setback to one foot. Under Section 11.2, Definitions, "Accessory" includes the original text from Section 5.227 and requires a setback of five feet instead of one foot for portable buildings. The Town must update the definition for "Accessory" to be consistent with the proposed text amendment for Section 5.227.
- 2 Section 11.2 includes a definition for "Portable Structure" instead of "Portable Building." The latter term is used under the definition for "Accessory" and Section 5.227. It is recommended that a consistent term is used throughout the code so that it can be more easily administered and understood.
- 3 Pursuant to New York State General Municipal Law (GML) Sections 239-m and 239-n, if any of the

conditions of this GML review are overridden by the board, then the local land use board must file a report with the County's Commissioner of Planning of the final action taken. If the final action is contrary to the recommendation of the Commissioner, the local land use board must state the reasons for such action.

The review undertaken by the County of Rockland Department of Planning is pursuant to and follows the mandates of Article 12-B of the New York General Municipal Law. Under Article 12-B the County of Rockland does not render opinions nor determines whether the proposed action reviewed implicates the Religious Land Use and Institutionalized Persons Act. The County of Rockland Department of Planning defers to the municipality referring the proposed action to render such opinions and make such determinations as appropriate under the circumstances.

In this respect, municipalities are advised that under the Religious Land Use and Institutionalized Persons Act, the preemptive force of any provision of the Act may be avoided (1) by changing a policy or practice that may result in a substantial burden on religious exercise, (2) by retaining a policy or practice and exempting the substantially burdened religious exercise, (3) by providing exemptions from a policy or practice for applications that substantially burden religious exercise, or (4) by any other means that eliminates the substantial burden.

Pursuant to New York State General Municipal Law §§ 239-m and 239-n, the referring body shall file a report of its final action with the County of Rockland Department of Planning within thirty (30) days after the final action. A referring body that acts contrary to a recommendation of modification or disapproval of a proposed action shall set forth the reasons for the contrary action in such report.

9. There is an errant 405.5 spot shot between the 402 and 403 contours in the southwest corner of the east basin. Please revise/relocate for clarity.
 10. Please add missing invert labels to the following structures:
 - CB-21B (plan and profiles)
 - FI-5 (plan and profile)
 - CB 6A (plan and profile)
 11. The applicant has indicated that infiltration testing shall be done prior to the Planning Board Chairman's endorsement. This would be atypical as the results of the testing could end up modifying the drainage design quite considerably and therefore is more common as a condition to be satisfied prior to Final Site Plan Approval. Ultimately it is the Planning Board's decision, but this would be the Drainage Consultant recommendation.
9. The Town of Orangetown Highway Department provided the following comments:
- The Emergency Access Road on Grotke Road will be maintained by way of an agreement between the Toll Brothers and Home Owners Association or by another legal document.
 - Bollards and chain proposed to control emergency ingress and egress to the proposed emergency road shall be located on private property. The plan presently indicates it will be installed in the Town Road Right of Way.
10. The applicant's attorney has provided previously requested documentation demonstrating that Gatto lane, within the Village of Chestnut Ridge, is a public road. The applicant's attorney also provided documentation demonstrating that the Village of Chestnut Ridge denied the applicant's request to improve/ widen Gatto Lane within the Village. EMERGENCY ACCESS EASEMENT

The Grantee is not obligated or required to provide prior notice to the Grantor before entering, re-entering or using the Emergency Access Easement Areas in accordance with this Emergency Access Easement.

The Grantor, or its successors or assigns, shall construct travel ways within the Emergency Access Easement Areas as shown on the Filed Map. The Grantor, or its successors or assigns as the owner(s) of the Property and the Emergency Access Easement Areas, shall maintain the Emergency Access Easement Areas in good repair and in an open and passable condition at all times and under all conditions, so they can be utilized by ordinary passenger vehicles, as well as police and emergency medical and fire vehicles during a State of Emergency. The Grantee shall have the right, but not the obligation, to inspect the Emergency Access Easement Areas to ensure Grantor's compliance with this paragraph. In addition to any and all other remedies available to the Grantee under law, if the Grantor shall fail to maintain the Emergency Access Easement Areas in good repair and in an open and passable condition at all times and under all conditions, the Grantee shall have the right, but not the obligation, to enter and re-enter the Emergency Access Easement Areas to repair and maintain the Emergency Access Easement Areas.


