This was a visit to the area where the complaint was reported. Odors were evident and ranged from mild to strong around Hayes Street and Arthur Street in Blauvelt. These odors were ALUF type odors consistent with melted and or burned plastic mixed with fragrance. The duration of the odor was at least one and one half hours that I stayed in the area. However, I received complaints and at later times, as late as 7:00 PM.

PLEASE TAKE FURTHER NOTICE THAT ECL §71-2103 provides that any person who violates ECL Article19 or any rule or regulation promulgated pursuant thereto shall be liable for a civil penalty of up to \$18,000, plus an additional penalty not to exceed \$15,000 for each day that the violation continues and that such person may be enjoined from continuing such violation.
