- 1. The Board found that the applicant proposed to install LED-Halo lit channel aluminum faced clear lexan backs letters, as noted on the submitted plan. Letters in the word "Georges" are a variety of sizes, largest letter is 21.5 inches, smallest letter is 13.75 inches. The letters in the words "Auto Body" are 8.5 inches. All letters are beige color, mounted on a brown background.
- 2. The Board found the sign would be illuminated during the hours of operation as well as the evening hours; the same hours as the prior signage on the business.
