Alarm User Instructions and Minimum Requirements Alarm System Law
Orangetown Local Law No. 5 / Nyack Village Code No. 2

Orangetown 1C-9 / Nyack 123-9 Minimum Requirements

Each alarm system within the Town of Orangetown / Village of Nyack MUST be equipped as follows before an Alarm User Permit can be issued.

- A. The alarm system shall contain an automatic audible signal cut-off device so that the maximum time an alarm shall cause an external audible alarm to be emanated does not exceed thirty (30) minutes per activation.
- B. The alarm system shall be equipped with a standby power source sufficient to maintain the system in a state of readiness for at least six (6) hours in the event of a power failure.
- C. Automatic dialer devices, upon a single stimulus shall not exceed two (2) separate calls to the Police Department and no such call shall exceed one (1) minute in duration. There must be a two (2) minute interval between calls, with the second call clearly identified as such.
- D. The contents of any recorded message to be transmitted to the Police Department must be intelligible and in the format approved by the Chief of Police as appropriate for that type of emergency reported.
- E. Automatic dialer devices shall be connected to the Police Department only via telephone numbers designated by the Chief of Police, for this purpose (845) 359-3851

Alarm Cancellation Code

Your Alarm Permit Number is also your Alarm Cancellation Code. In the event your alarm is activated in error and you wish to abort the signal, you MUST call the Orangetown Police at (845) 359-3700 and give your Name, Address and Cancellation Code Number. Properly canceled alarms will not be charged against your account as a false alarm. It is your responsibility to see that all persons authorized to use your alarm are aware of this procedure.

Silent alarms, as well as panic alarms are considered a manually activated emergency signals and as such are not usually verified prior to police dispatch. You can cancel these signals as described above, but any deactivation in the procedure will be considered an indication that the alarm is in fact VALID.

Changes in Information

If for any reason it is necessary for you to change information on your Alarm User Permit, you must make any changes IN PERSON at the Town of Orangetown Police Department. Be sure to bring your permit with you and note that all changes must be made at least two (2) days prior to their taking effect.

VIOLATIONS OF THIS LOCAL LAW OR MORE THAN FOUR (4) FALSE ALARMS WITHIN ANY TWELVE (12) MONTH PERIOD CAN RESULT IN ISSUANCE OF A SUMMONSE FOR VIOLATION OF THIS LOCAL LAW RESULTING IN A FINE AND OR SUSPENSION OF YOUR PERMIT
