

NOTICE OF ANNUAL ELECTION
SPARKILL-PALISADES FIRE DISTRICT

PLEASE TAKE NOTICE that the Annual Election of the Sparkill-Palisades Fire District will take place on December 12, 2017, between the hours of 6:00 P.M. and 9:00 P.M. at the firehouse located at Route 340, Sparkill, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2018 and ending December 31, 2022; and

To vote upon the following resolution:

SHALL the bond resolution of Sparkill-Palisades Fire District, in the Town of Orangetown, Rockland County, New York, entitled: "BOND RESOLUTION OF SPARKILL-PALISADES FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF ORANGETOWN, ROCKLAND COUNTY, NEW YORK, ADOPTED NOVEMBER 7, 2017, AUTHORIZING THE CONSTRUCTION OF AN ADDITION AND RELATED IMPROVEMENTS TO THE EXISTING FIREHOUSE LOCATED AT 520 ROUTE 340, SPARKILL, NEW YORK, INCLUDING THE PURCHASE OF ORIGINAL FURNISHINGS, EQUIPMENT, MACHINERY OR APPARATUS AND ANY ANCILLARY OR RELATED SITE, DEMOLITION AND OTHER WORK REQUIRED IN CONNECTION THEREWITH ("PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$5,400,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND TO THE FINANCING THEREOF; APPROPRIATING SAID AMOUNT THEREFOR; AUTHORIZING THE ISSUANCE OF BONDS IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$5,400,000 TO FINANCE SAID APPROPRIATION; STATING THAT THE PLANNING BOARD OF THE TOWN OF ORANGETOWN, ACTING AS LEAD AGENCY PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT, HAS HERETOFORE DETERMINED THAT THE PROJECT IS AN UNLISTED ACTION AND A NEGATIVE DECLARATION HAS BEEN ISSUED AND FILED; STATING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID PROJECT IS TWENTY-FIVE (25) YEARS AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE," BE APPROVED?"

All residents of the Sparkill-Palisades Fire District, who are duly registered to vote with the Rockland County Board of Elections on or before November 20, 2017 shall be entitled to vote at this election.

Any person desiring to have his or her name appear on the ballot for the above office must have filed a written request with the Secretary of the Fire District not later than November 22, 2017.
